#### Informasi Lain

Berdasarkan Peraturan Bursa Efek Indonesia (Bursa) Nomor I-I tentang Penghapusan Pencatatan (Delisting) dan Pencatatan Kembali (Relisting) Saham di Bursa, Bursa dapat menghapus saham Perusahaan Tercatat apabila:

a. Ketentuan III.3.1.1, Mengalami kondisi, atau peristiwa, yang secara signifikan berpengaruh negatif terhadap kelangsungan usaha Perusahaan Tercatat, baik secara finansial atau secara hukum, atau terhadap kelangsungan status Perusahaan Tercatat sebagai Perusahaan Terbuka, dan Perusahaan Tercatat tidak dapat menunjukkan indikasi pemulihan yang memadai.

b. Ketentuan III.3.1.2, Saham Perusahaan Tercatat yang akibat suspensi di Pasar Reguler dan Pasar Tunai, hanya di diperdagangkan di Pasar Negosiasi sekurang-kurangnya selama 24 (dua puluh empat) bulan terakhir.

Sehubungan dengan hal tersebut di atas dan Pengumuman Bursa No.: Peng-SPT-00012/BEI.PP3/08-2019 tanggal 5 Agustus 2019 perihal Penghentian Sementara Perdagangan Efek PT AirAsia Indonesia Tbk (CMPP), maka saham PT AirAsia Indonesia Tbk. (Perseroan) telah disuspensi selama 7 bulan dan masa suspensi akan mencapai 24 bulan pada tanggal 5 Agustus 2021.

#### Other Information

Based on the Indonesia Stock Exchange (IDX) Regulation Number I-I concerning Delisting and Relisting of Securities at the Exchange, the Exchange shall delist the shares of the Listed Company if:

- a. Clause III.3.1.1, experiencing a condition, or an occurrence constituting a material adverse effect , which significantly gives a negative influence to the business existence of the Listed Company, either financially or legally, or to the existence status of the Listed Company as a Public Company, and the Listed Company cannot demonstrate a sufficient recovery and indication of a sufficient remedy;
- b. Clause III.3.1.2, The shares of the Listed Company which resulted from the suspension at the Regular Market and the Cash Market, shall are only be traded at the Negotiable Market at the latest for the last 24 (twenty four) months. In relation with the foregoing and the Stock Exchange Announcement No.: Peng-SPT-00012/BEI.PP3/08-2019 dated August 5, 2019 concerning the Temporary Suspension of Securities Trading of PT AirAsia Indonesia Tbk. (CMPP), the shares of PT AirAsia Indonesia Tbk. (The Company) has been suspended for 7 months and the suspension period will reach 24 months on August 5, 2021.
